SPECIFICATIONS AND PRICING

1. DESCRIPTION: The purpose of this Invitation to Bid (ITB) is to obtain a contractor to provide Bar Coded Property Labels for use by the Ohio Rehabilitative Services Commission.

2. QUANTITY: 7,500 (exact quantity).

3. UNIT PRICE AWARD: Bidder shall not insert a unit cost more than 3 digits after the decimal point. Digit(s) beyond 3, after the decimal point shall be dropped by DAS and not used in evaluation and any subsequent award. To determine the low lot total price of the ITB, the state will multiply the estimated usage of each item by its corresponding unit price and add the totals together. Failure to bid all items will disqualify your bid.

4. SPECIFICATIONS: 2 ½" x 7/8" Void PET w/color, Bar Coded Label, printed one side, laminated, "Property of OOD", reverse printed in red, number/bar coding in black, 500 per roll.

A. SIZE: 2 ½" x 7/8" rounded corners.

B. STOCK: White void polyester, laminated with clear polyester, 10mil. Label adhesive must be permanent.

C. PRESSWORK: Printed one side. PMS 195 Red & black consecutive numbering / bar coding Starting number 300000, Ending number 307500. No missing or duplicate numbers.

D. NUMBERING: Starting number 300000, Ending number 307500. No missing or duplicate numbers.

E. INK: Black numbering & barcoding, "Property of OOD" reverse printed in red

F. BINDERY: roll labels on 3" core, 500 per core. Rounded corners, waste removed

G. FINISHED TRIM SIZE: 2 ½" x 7/8".

H. TYPESETTING: Awarded may need to set two lines of text "Property of OOD" bar code and number.

I. SUPPLIED TO VENDOR: Previously printed label, FOR LAYOUT PURPOSES ONLY, will be furnished to the selected vendor. Return all state supplied materials to the proof to person.
